FY14-15 Accomplishments

- **Assisted five households in becoming homeowners when they purchased homes rehabilitated by the Trust**, all located in Easton's West Ward. All Trust homeowners are entitled to vote on major Trust decisions and have the opportunity to serve on the organization's committees and board of directors.
- **Experienced first resale** when a Trust homeowner in Easton sold their home. The resale process and assignment of the associated ground lease went smoothly.
- **Acquired three newly-constructed townhomes** in Catasauqua, broadening the Trust's portfolio and marking our initial offering of new construction units.
- **Initiated a closer partnership** with the City of Bethlehem through the acquisition of a vacant home in south Bethlehem from the Bethlehem Redevelopment Authority. Rehabilitation of this home began in mid-2015. As with all Trust home rehabilitations, the most important historical and architectural features of this home will be preserved, while the home is modernized with environmentally sound and energy-saving improvements.
- **Launched the County-Wide Housing Rehabilitation Program** on behalf of Northampton County. This program provides low-income homeowners in Northampton County with interest-free, partially-forgivable loans to repair their homes to meet health, safety and building code standards, and coordinates the completion of repairs. Two homes were rehabilitated through the program.
- **The Lehigh Valley Community Land Trust** is a separately-incorporated subsidiary of the Community Action Committee of the Lehigh Valley.
